CONSTRUCTION SPECIFICATION 409 - GEOCELL STRUCTURES

Construction Specification 409 – Geocell Structures

1. Scope

Items within this specification are for geocell installation. This specification shall follow all manufacturer specifications.

2. Measurement and Payment

Method 1—For items of work for which specific unit prices are established in the contract, each area treated calculated to the nearest square foot (SF). Payment for treatment is made at the contract unit price for the designated treatment, which will constitute full compensation for completion of the work.

Method 2—For items of work for which specific lump sum prices are established in the contract, the quantity of work will not be measured for payment. Payment for this item is made at the contract lump sum price for the item and will constitute full compensation for the completion of the work.

3. Items of Work and Construction Details

All payment requests, with each invoice, shall be accompanied by complete documentation and supporting data in accordance with **Construction Specification 7**.

A. Bid Item 11; Furnish and Install Concrete Pad.

- 1) The Contractor shall install a geocell pad in accordance with the project's construction drawings. Geocell shall be 8 inches in depth and filled with railway ballast stone (4 to 6 inches, per rock specification) to a total depth of 12 inches.
- 2) All work shall conform to manufacturer specifications, as well as any other applicable specifications referenced within that section. Compliance with these standards is required for the execution of this bid item.
- 3) All payment requests, with each invoice, shall be accompanied by complete documentation and supporting data in accordance with **Construction Specification 7**.
- 4) Payment for **Bid Item 11** shall be made in accordance with **Method 2** as outlined in **Section 2** of this construction specification.
