At that time the Bids received will be publicly opened and read.

The Project includes, but is not limited to, the following Work:

- Erosion and sedimentation controls;
- Concrete resurfacing of the tipping floor;
- Repair of the existing tipping floor slab overhang;
- Concrete repairs to the existing transfer station retaining walls and push walls;
- Underpinnings of the building foundations;
- Earthwork;
- Site preparation & clearing;
- Unclassified excavation;
- Placement of structural fill;
- Gravel pad Installation;
- Retaining wall construction;
- Concrete slab construction;
- Stormwater Conveyance Channels; and,

Bidder Qualifications

The successful bidder shall be a general Contractor in the State of North Carolina, who has experience with the following but not limited to:

- Concrete retaining wall construction;
- Concrete slab construction;
- Underpinnings of the building foundations;
- Transfer Station tipping floor resurfacing; and,
- Storm water conveyance systems.

Qualifications Statement Section 00451 will be used to evaluate the Bidder's experience record. At least two (2) projects totaling 200 linear feet of constructed retaining wall, and construction and/or restoration of at least 10,000 square feet of transfer station tipping floor within the last five (5) years is required to have been successfully completed by the General Contractor. A North Carolina General Contractor License is required for this project.
